Why Central Asia Think Tank Network ?




- Central Asia's immense economic growth potential

Organization Structure of Central Asia Think Tank Network

- General Body: Final Decision Making Authority (All members);
- General Council: (Members Sr. Intellectuals, Renowned Academics, Sr. Policy Makers – Chairs is very Sr. policy makers (e.g. Ex- PM)
- Secretariat: Coordination and Management Body

The secretariat of CATTN will be a standing body specifically responsible for:

- (i) Specific preparations and implementations of all meetings and activities;
- (ii) Executing resolutions of General Body and Governing Council;
- (iii) The preparations of annual work plan and budget reports;
- (iv) Mobilizing funds and drafting rules and regulations
