Closing remarks for the final workshop on TVET TA

As skills development worldwide improves fast, there is a risk that the region could be left behind and suffer from a "brain drain" situation as its talented workforce is attracted to work elsewhere. The region needs to improve its skill standards to be more competitive to provide a solid basis for increased foreign direct investments and people-to-people connections.

CAREC Institute, by its mandate, is a knowledge hub to provide quality research and capacity-building activities and facilitate knowledge-sharing for CAREC member countries. Today's workshop offers an excellent opportunity to share the PRC's TVET experiences and insights on its replicabilities in other CAREC member countries.

PRC has encountered similar challenges in developing the TVET. Since the reform and opening-up, the PRC economy has generated strong demands for professional and skilled labor. The country has made great progress in many fields of TVET in recent years. The final TA report has provided 8 suggestions for TVET development for other CAREC member countries. It covers TVET infrastructure investment, the improvement of teaching, better matching with the labor market and the partnership with the enterprises, adopting new technology, and regional cooperation on TVET, etc.

Besides those, during today's workshop, ADB colleagues, TVET experts from Georgia, Uzbekistan, Tajikistan and PRC, and my CI colleagues just shared excellent insights from different perspectives, which could help us to learn better from the PRC's experience and understand better how these experiences and suggestions could be scaled up to other CAREC member countries.

In conclusion, I would say today's workshop is a very informative workshop. I don't have much to add. CAREC Institute will continue to work with our member countries and development partners on this important topic.
