About the Event

This year's East Asia Forum (EAF) will explore ways the People's Republic of China (PRC) and ADB can foster partnerships in addressing regional challenges related to climate change with a special interest in promoting global and regional public goods in ADB's developing member countries (DMCs).

The Forum will have four sessions. The first session will explore strategic ways the PRC and ADB can further evolve their partnership in tackling regional challenges including climate change. The second and third sessions will focus on two critical parts of climate as public goods and explore best practices for promoting them. Specifically, session 2 focuses on nature conservation and ecosystem protection, and how instruments like nature-debt swaps can be a viable financing instrument to help DMCs meet their commitments to conserve 30% of terrestrial and marine areas by 2030. Session 3 centers on addressing climate mitigation through accelerating the energy transition from fossil fuel powered energy to clean energy, drawing on international practices related to energy policy, investments and transition financing. The fourth session discusses how artificial intelligence can support addressing regional challenges. Specifically, it will look at emerging best practices in strategy, policy, and regulation to enhance the potential benefits of AI while also mitigating the potential costs.

Each session will comprise a keynote speaker setting the context and regional challenges, followed by an interactive panel discussion comprising four to five distinguished experts.

In addition to the four sessions, ADB will also launch its publication *Echoes of Success: Case Studies in the Replication of Asian Development Bank Projects in the People's Republic of China.* The report presents five ADB-financed projects in the PRC that have been replicated within and outside the PRC.

The event will be held at the Grand Ballroom 2, Kerry Hotel, 1 Guanghua Road, Beijing.



1. About the Project

Loan 3629-PRC: Air Quality Improvement in the Greater Beijing-Tianjin-Hebei Regional Emission-Reduction and Pollution-Control Facility

The project is to support air quality improvement in the greater Beijing-Tianjin-Hebei (BTH) region, and directly address barriers in deploying high level technologies that reduce air pollution from industries, urban infrastructure, and agriculture. It was approved for €428,000,000 and became effective on 15 January 2019, the closing date is 30 November 2025. As of 30 May 2024, the project approved 19 subprojects, with 11 subprojects financed from ADB loan proceeds.

The Tianjin Dongli Biomass Energy and Comprehensive Waste Treatment Subproject is to comprehensively recycle and re-use waste to reproduce ether extract from kitchen waste and soil-aggregate subgrade and regenerated bricks from construction waste. Furthermore, there is also biomass power generation in the subproject. This subproject achieves both financial return and economic return in terms of emission reduction and energy saving.
